

**Liability Waiver**

I fully understand that staff members are not physicians or medical practitioners of any kind. With that in mind, I hereby release the staff of JDJ Performing Arts LLC, JDJ Performing Arts of Norwalk, LLC (dba Superstars Performing Arts) and JDJ Performing Arts of Grimes, LLC (dba Grimes Superstars) to render temporary first aid to my child in the event of any injury or illness, and if deemed necessary by the staff to seek medical help, including transportation by staff member and or its representatives, whether paid or volunteer, to any health care facility, or the calling of an ambulance for said child should the staff deem this to be necessary.

We, the staff JDJ Performing Arts LLC, JDJ Performing Arts of Norwalk, LLC (dba Superstars Performing Arts) and JDJ Performing Arts of Grimes, LLC (dba Grimes Superstars), recognize our obligation to make our students and their parents/guardians aware of the risks and hazards associated with the sport of twirling, tumbling, trampoline, cheerleading, dance, acrobatics, and/or specialized sports training. Students may suffer injuries, possibly minor, serious or catastrophic in nature. Twirling, Tumbling, Cheerleading, Dance, Acrobatics, and/or Specialized Sports Training can be dangerous and can lead to injury or death. I also understand that it is the parents' responsibility to warn the child about the dangers of injury. Staff will only warn the child through "Safety Messages" and our teaching style and progressions.

Coaches, teachers and other staff members, will not accept responsibility for injuries sustained by any student during the course of Twirling, Tumbling, Trampolining, Acrobatics, Cheerleading, Dance, and/or Specialized Sports Training open workouts, or in the course of any exhibition, competition or clinic in which he or she may participate or while traveling to or from the event.

With the above in mind, and being fully aware of the risks and possibility of injury involved, I consent to have my child or children participate in the programs offered by JDJ Performing Arts LLC, JDJ Performing Arts of Norwalk, LLC (dba Superstars Performing Arts) and JDJ Performing Arts of Grimes, LLC (dba Grimes Superstars), and/or its representatives whether paid or volunteer.

**COVID-19 Liability Release Waiver**

The World Health Organization has declared the novel Coronavirus (COVID-19) a worldwide pandemic. COVID-19 Policy Additions:

- I agree that if my student or any member of the student's household is experiencing any symptoms of fever, fatigue, difficulty breathing, or dry cough or exhibiting other symptoms related to COVID-19 as documented by WHO, CDC and/or local public health officials, my student will not participate in studio activities and will avoid the premises while experiencing the symptoms and for a minimum of 14 calendar days from the last day of symptoms.
- I agree that if my student or household family member is diagnosed with COVID-19 or has had direct exposure to a person diagnosed with COVID-19 my student will not participate in any studio activities and will avoid the premises for a minimum of 14 calendar days from the date of the positive test confirmation.

*Note: Due to other regulations and laws JDJ Performing Arts LLC cannot mandate participants to notify us of a positive test result. We appreciate any transparency of a positive test to take the necessary additional precautions in conjunction with local public health officials.*

Following the pronouncements above I hereby declare the following:

- I am aware of the existence of the risk by participating in the activities offered by JDJ Performing Arts LLC, JDJ Performing Arts of Norwalk, LLC (dba Superstars Performing Arts) and JDJ Performing Arts of Grimes, LLC (dba Grimes Superstars) that may cause illness such as but not limited to Influenza, MRSA or COVID-19. I personally understand the risk of transmission of such viruses are possible while participating in these activities.
- With full knowledge of the risk involved, I hereby release, waive, discharge JDJ Performing Arts LLC, JDJ Performing Arts of Norwalk, LLC (dba Superstars Performing Arts) and JDJ Performing Arts of Grimes, LLC (dba Grimes Superstars), its owners, directors, staff, independent contractors, affiliates, vendors and assigns from all liabilities, claims, demands, actions and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, injury, or death that may occur related to COVID-19 while participating in any activity while in, on or around the premises or while using the facilities that may lead to unintentional exposure or harm due to COVID-19.
